OPERATING BUDGET'S OFFSETTING REVENUE

Carina states that revenues are down due to not receiving the ARPA Grant or Bridge Aide. She also states that last year we got a one-time double payment for the Highway Block Grant and the State Grant is not listed because we don't know how much we will receive year to year. The SRO revenue is not here because it's a warrant article that hasn't been voted on yet. Carina states that she will need to update the summary column to be sure all the money is listed correctly.

TOWN CLERK/CEMETERY RECORDS SOFTWARE: Motion to recommend funding in the amount of \$10,000, Tammy, Second: Herb

Discussion: Mike asks how this software will be used. Tammy states the Town Clerk asked that the Cemetery Trustees put this in their budget, but they chose not to and they like the way it's done now. The Town Clerk is asking for this to make it easier and so the maps are accurate. For: 9 Opposed: 3 Abstain: 0 Motion carries unanimously

PD VEHICLES (NEW CRUISER): Motion to recommend funding in the amount of \$61,857.00, Tammy, Second: Herb

Discussion: Brian asks if the capital reserve can be used to purchase cruisers. Tammy states that it's used for non-vehicle purchases.

For: 12 Opposed: 0 Abstain: 0 Motion carries unanimously

COLLECTIVE BARGAINING AGREEMENT YEAR 1: Carina states that we can't talk about the specifics or vote on this until the agreement is ratified by the union. This will be tabled until Thursday's meeting.

SRO-SCHOOL RESOURCE OFFICER YEAR 1: Motion to recommend funding in the amount of \$120,000.00, Mike, Second; Herb

Discussion: Tammy states that there is an estimated offsetting revenue in the amount of \$100,000.00 for the first year, which includes \$18,000.00 from the school. Carina states that the SRO will be on the operating budget for the police next year.

LEASE/PURCHASE AGREEMENT FIRE TRUCK YEAR 1: Motion to recommend funding in the amount of \$450,000.00. Tammy, Second: Herb

Discussion: All asks if they looked at buying a used truck. They discussed this, but it was decided to buy new. Carina states that the money for this is as follows: \$214,000 in CIP, we just added another \$150,000.00 and \$450,000.00 from the Undesignated Fund Balance. Carina states that of the \$150,000.00: \$100,000.00 is for the new pumper, \$25,000.00 is for a tower truck and another \$25,000.00 is for the E-1 pumper.

ROUTE 3 WATER MAIN UPGRADES-CONSTRUCTION BOND: Motion to recommend funding in the amount of \$2,200,000.00, Tammy, Second: Herb

Discussion: Brian asks what the interest rate for a 10-year bond will be. Carina states that the local banks estimated that at 4-5%, but those are subject to change and they would need to get updated figures. Brian states that the \$1.75 tax impact is over the life of the bond, not per year.

ROUTE 3 WATER MAIN UPGRADES-ENGINEERING: Tammy states that if the construction bond does NOT pass then they will try for just the engineering bond, but if the construction bond passes then the engineering bond will be dropped. Motion to recommend funding in the amount of \$325,000.00 Mike, Second: Herb

For: 12 Opposed: 0 Abstain: 0 Motion carries unanimously

NEW POLICE STATION - CONSTRUCTION BOND: Motion to recommend funding in the amount of \$8,500,000.00. Mike, Second: Ray

Discussion: Originally when this was for a police/fire station, it came back at \$24,000,000.00, so the design firm revised their plans for just a 14,000-15,000 square foot police station at \$8,500,000.00. The police station is the greatest need and fire station can just get some upgrades. Members feel this is not a reasonable amount to ask for from our

community. There was a committee for the police/fire department that met for over a year and presented a conceptual design to the BOS and then the committee and community weren't advised or consulted again. Some members have looked at what other cities have paid for their police/fire stations and think that a combination building can be done for much less that \$24,000.000.00. We don't want to give up on this combination building idea, but we don't feel right paying this much for just a police station. There should be a way to pursue grants also.

Paul states that the advertisement for the bond should have been listed with the specific bonds and amounts. Carina states that since these numbers had not been finalized, they didn't want to confuse people, so they advertised it without the amounts.

Motion: "Table the vote on the new police station until Thursdays after the bond hearing, but prior to the public hearing." Brian, Second: Tammy

Discussion: Members give their opinions on whether to table or not and what difference that will make and whether more information will change minds. Cindy moves the question. For: 6 Opposed: 6 Motion does not pass

Back to the original motion:

For: 1 Opposed: 10 Abstain: 0 Motion fails (not recommended)

NEW POLICE STATION – DESIGN/ENGINEERING: Motion to recommend funding in the amount of \$400,000.00. Tammy, Second: Herb

Discussion: This \$400,000.00 is to design/engineer just for just the police station? From our \$80,000.00 last year, we have a conceptual design for a \$24,000,000.00 police/fire station and an \$8,5000,000.00 police station. The building committee met with the BOS, with 32 recommendations on how to cut costs. Cindy moves the question.

For: 1 Opposed: 10 Abstain: 0 Motion fails (not recommended)

We cannot vote on the totals for SPECIAL WARRANT ARTICLES, CRF/TRUST FUNDS and the GRAND TOTAL because the collective bargaining agreement has not been ratified. These will be tabled until Thursday.
