REVIEW AND APPROVAL OF MINUTES:

Motion: Herb 2nd: Dennis

Discussion: Tracey states that the following corrections need to be made:

Line 10: spelling mistakes on Charyl, Roberta and Kara's names.

Line 13: spelling mistake on Carina's name

Line 26: It should say, "...was increased for..."

Line 27: It should say, "the C and D container needs..."

Line 34: It should say, "They have to compete with..."

Line 35: The word counselors needs an apostrophe after the s

Line 41: spelling mistakes on Tara, Kara and Charyl's names

Tammy states that on Line 31 Tara Tower's name is spelled incorrectly and on the same line it should say, "Woodstock asked if..." On line 32 it should say, "...wages will be adequate to get enough employees."

REVIEW AND VOTE ON RECOMMENDATION OF BUDGETS:

#1 EXECUTIVE: Line items of budget listed with totals (see budget) Motion to approve and recommend at \$523,276.00, Herb, 2nd: Tammy

Discussion: Members discuss reasons the budget increased and specific line items that can possibly be cut to get the rate of increase closer to the rate of inflation.

Carina suggests getting an Ipad or a laptop instead of a Surface Pro. Motion made to reduce the Surface Pro line item to \$5,000, Tammy, 2nd Susan. Discussion: There will also be a lower annual fee. For: 8 Opposed: 0 Motion passes unanimously.

Tammy states that the holiday party doubled due to it going back to the amount from 2 years ago. Paul states that the total budget was underspent by \$457,000. Mike states that

being underspent does not necessarily mean they didn't need it. Carina states that being understaffed affected the amounts not spent in payroll taxes, wages, retirement, health insurance etc. Tammy states that \$326,000 was given back to the taxpayers. Carina states that we are required to have a 5-17% unexpended fund balance. Johnna states that, at the beginning of 2021, department heads were told to watch their spending while they waited for the budgets to be approved. After that they were told to watch spending because the town didn't have the cash flow to pay bills until the tax bills come in. The reevaluation of the town slowed that down also. Paul feels the raises given under wages are too high.

Paul suggests that we cut the Highland Games line item. Mike and Brent state that it brings in a lot of revenue to the town. Motion made to reduce the Highland Games line item to \$2000, Susan, 2nd Jim. Discussion: The amount of \$6,800 was specifically asked for to cover the police detail. For: 3 Opposed: 6, Motion fails.

The total is now changed to \$523,236.00.

#7 TOWN HALL BUILDING: Line items of budget listed with totals (see budget) Motion to approve and recommend at \$83,340.00, Herb, 2nd: Cindy Discussion: Jim makes a motion to reduce the total by \$5,140.00 for carpeting, 2nd: Paul

Paul states that the money for the carpet and vinyl should come from CIP not the operating budget. Johnna states that the minimum for projects is \$15,000.00. Paul states that projects can be combined to reach that \$15,000.00 minimum. Tammy states that this is not budgeted for in the CIP and it needs to get gone. Paul states that taking that amount out doesn't mean it won't get done. It just means it can be done under the CIP.

Jim withdraws his motion. Paul makes a motion to take out \$15,640.00, for carpet and vinyl, 2nd: Brent, For: 7 Opposed: 2 Motion carries. The total is now changed to \$67,700.00. For: 9 Opposed: 0 Abstain: 0 Motion carries unanimously for funding at \$67,700.00.

Motion to approve and recommend at \$37,830.00, Herb, 2nd: Dennis
Discussion: Paul states that the Road Rebuild line item amount of \$10,000.00 should be removed and the project should be completed under the CIP.

Paul makes a motion to reduce this budget by \$10,000, 2nd: Brent. Discussion: Tammy states that this is not planned for in the CIP and is not an accepted practice. Jim states that there is a surplus in the CIP. Johnna states that the CIP description says that projects are to be a minimum of \$15,000 and that is not being held to. Tammy states that projects should be saved for over a number of years, so that a warrant is not necessary.

Discussion: Paul asks about whether property liability insurance for the community center will be split with Woodstock. Carina states that after Town Meeting, when they have their joint meeting with Woodstock, they will amend the amount being asked for.

Discussion: Mike states that maybe there is some room to reduce this budget. Tammy states that in other budgets we reduced by specific line items. Mike states that although we may be talking about a specific line item, we are really just reducing the total and how the department heads then choose to spend that total is up to them. Paul suggests that, at the beginning of budget season, we come up with a percentage that we want to hold the budget to, so that we don't see these large increases. Johnna states that the regular wages and holiday pay are mandated by the union contract and can't be touched. Tammy states that under part-time wages we are saving money because benefits, retirement and insurance are not included. Cindy states that the only areas that increased were wages, fuel and training. Dennis states that the town is growing and we need these officers.
