CALL MEETING TO ORDER.

Chair Robinson called the meeting to order at 9:02 AM.

MINUTES:

b. Project Number 37: "*Hanson Farm Road Reconstruction (See Note)":

- i. Move \$47,543 in the "*Hanson Farm Road Reconstruction (See Note)" to Project Line Number 71 "*Reclaim & Pave West Street and Engineering".
- ii. Change title from "Reclaim Edgewood & Coolidge Roads" to "Reclaim Edgewood & Coolidge Streets".

c. Project Number 71: "*Reclaim & Pave West Street and Engineering":

- i. Move "\$31,850" in interest to Project Line Number 71 "*Reclaim & Pave West Street and Engineering".
- ii. Move \$47,543 in the "*Hanson Farm Road Reconstruction (See Note)" into Project Line Number 71 "*Reclaim & Pave West Street and Engineering" in to the CRF Balance 12/31/2019 column, adding to \$708,877.

f. <u>Delete: "Note on Hanson Farm Road: To be funded from non-CRF sources.":</u>

7. Page 27, VIII. 1310-316 Solid Waste:

a. Subtotal Un-Allocated CRF Balance of \$2,189

Finance Director Johnna Hart suggested moving moneys from the Un-Allocated CRF Balance to one of the line items or project numbers that needs additional moneys. Discussion regarding moving moneys internally to cover the cost of purchasing the truck scale under Project Number 59 and Replacing the Roof under Project Number 88 as neither of those accounts had enough money in them to pay for the needed expenses.

b. Project Number 30: "Repave Recycle Center Roadway":

- i. Change CRF balance 12/31/2019 from \$45,000 to \$30,000.
- ii. Add \$15,000 to FY 2021.

c. Project Number 88: "Facility & Land Improvements & Replacements":

- i. Change CRF balance 12/31/2019 from \$14,815 to \$0.
- **d.** After discussion, they decided to propose as follows:

Motion to approve the following:

i. Take \$2,000 out of the \$3,002 of Un-Allocated CRF Balance to help pay for project at the Kanc Ski Slope, leaving a remainder of \$1,002 in

the Un-Allocated CRF Balance;

- ii. Move \$15,000 from Project Number 30 "Repave Recycle Center Roadway "to Project Number 88 "Facility & Land Improvements and Replacements" for roof repairs.
- iii. Move \$50,000 from Project Number 29 "Solid Waste Existing Equipment Replacement Fund" to Project Number 59 "Install Truck Sale at Solid Waste Facility" to pay for purchasing the Solid Waste Truck Scale.

Motion: Budget Committee Member Paul Beaudin. Second: Town Manager Burbank. All in favor.

8. Page 27, IX. 1310-321 Kanc Equipment. B. Ski Slope:

Discussion about how the cost of the Ski Slope Infrastructure is \$26,000 PLUS \$16,000 for a total of \$42,000. The CIP Committee members suggested replacing the line that reads: "Misc. Maintenance/Repair/Replacement" at the end of the B. Ski Slope list with Project Number 108.

- a. Project Number 78: "Repair/Replace Bombardier Groomer 2005":
 - i. Take \$26,000 out of the CRF Balance 12/31/2019.
- b. <u>Project Number 79: "Repair/Replace Caterpillar Diesel Tow Engine</u> Groomer":
 - i. Take \$14,000 out of the CRF Balance 12/31/2019.

Motion to approve these changes as shown on the new October 8, 2019 spreadsheet: Motion: OJ Robinson. Second: Town Manager Burbank. All in favor. (3-0).

- 9. Page 29, X. B. 1310-310 Library Building:
 - a. Project Number 18: "Library Building Infrastructure":
 - i. **Line a. Paint Town Library Exterior**: Take -\$2,350 out of the CRF Balance 12/31/2019.
 - ii. Line d. Replace Flooring in Library: Subtract \$2,350 from \$12,000.

POLICE DEPARTMENT

The CIP Committee agreed to make no more changes:

- 1. Page 23, IV. 1310-309 Police Department
 - a. Project Number 10 "Upgrade Police Department Computer System"
 - b. Project Number 21 "Town Wide Dispatch Communications Improvements":
 - i. **Phase 1:** New antennas.
 - ii. Phase 2: New radios. [Phase 1 and 2 cost was \$97,000 from Ossipee Mountain Electronics.]
 - iii. <u>Phase 3</u>: Upgrade radio system to Simulcast system (primarily software) to improve overall communications coverage, minimizing dead spots. It

will improve coverage of portable radios and improve coverage inside buildings. Originally budgeted for \$178,000, however, the cost is now up to \$200,000 due to cost increases for hardware.

iv. Phase 4: Replace console (hardware). Budget \$100,000

Discussion re: Handout for Police Dispatch Center Upgrade.

Town Manager Burbank explained that upgrade projects scheduled for 2016, 2017 and 2018 were never done. It will cost \$400,000 to do a total upgrade in order to continue to maintain our own Dispatch Center. Now we have two police dispatch clients: Campton and Woodstock. We can handle the two (2) additional towns police dispatching with our current full and part time staff. We have minimum staff requirement for 24/7 coverage of six (6) full time people. Currently they all receive overtime pay.

Paul Beaudin asked if the Town could look into qualifying for grant monies from the US Forest Service or Homeland Security. Burbank explained that the Town applied for grants in the sum of \$300,000. If the town's dispatch center is "regional" versus servicing only one municipality there is a better chance of qualifying for a grant.

Town Manager Burbank explained that in order to upgrade the Town will have to replace 20-year-old equipment. In addition, there will be annual \$4,800 maintenance costs. At this time the two towns' fire dispatch is staying with the Grafton County Dispatch System due to the mutual aid commitments. At this time the savings to the two towns of joining Lincoln is substantial: \$30,000 per year versus \$65,000 and \$68,000 per year at the Grafton County Dispatch Center.

Motion to go with the changes to the Dispatch CIP Budget as shown on the October 8, 2019 spreadsheet. Motion: Burbank. Second: Robinson. All in favor. (3-0).

1. Page 23, V. 1310-304 Fire Department

After discussion the no changes were made:

180	Town Manager Burbank said he had asked the two chiefs to look out 25 years (not 3) and
181	estimate their department needs. The Police Department has outgrown the space downstairs.
182	The Fire Department is close. What he is seeing politically with the neighboring towns Burbank
183	said he thinks Lincoln will have to go it alone as far as safety services. "We are currently
184	experiencing a volunteer crisis." We are going to have to move to full time paid employees for
185	both fire and emergency services. The Town of Lincoln is getting more than 3,300 calls per year
186	We need to ask for a "Needs Assessment". Do we need to look for and to cultivate community
187	support? Should the Town Offices be included in the public safety services building?
188	Town Manager Burbank went over the history of the Town Offices building from its inception as
189	a garage for the Paper Mill to its most recent renovation back in the 1990's. At this time the
190	Town needs \$57,000 just to fix the air conditioner system and to upgrade all the air conditioning
191	units in the building on Main Street. He talked about the consequences of not attending to
192	maintenance items in a timely way for all of the municipal buildings. He talked about the
193	increasing amounts of DPW time that has to be dedicated to building maintenance due to our
194	history of long-deferred maintenance. In the near future the Town will need a Director of
195	Buildings and Grounds.
