PUBLIC WORKS DIRECTOR PRESENTATION RE: WATER

Director of Public Works (DPW) Nate Hadaway submitted a new PLC Request Worksheet to the CIP Committee for a new PLC. Robinson asked what a PLC was. DPW Hadaway then tried to explain what a PLC is and what tasks it performs.

The CIP Committee members discussed and agreed to make the following changes:

- x. Change sum "Remaining After 2024 from \$121,762 to -3238;
