Dear Selectman and Town Manager,

For the safety of our townspeople and the betterment of the community I request that the town of Lincoln, NH extend the sidewalk on Pollard Road from where it currently ends at the intersection of Church Street though the entire length of the road.

I grew up on Pollard Road and live there now with my husband and children and we walk and bike along the road most days so I am acutely aware of what it is like to travel that road without a sidewalk. I work as an emergency physician at Dartmouth Hitchcock Medical Center and public safety is a natural focus of my work.

The lack of sidewalk poses a risk to public safety. As traffic has increased in Lincoln, Pollard Road has become a frequent alternative to Main Street for vehicular traffic. At the same time there are a significant number of people walking, running and biking along the road. There is no shoulder and it has become increasingly dangerous especially in the winter months when the Loon shuttle buses travel the road and snow banks and inclement weather impair visibility. I frequently find myself shuttling my children onto lawns as cars pass. The extension of the sidewalk would be an important improvement to public safety and would also better the community by connecting the sidewalks of a frequently traveled loop.
