## **Trustees of the Trust Funds**

Town of Lincoln, NH Meeting Minutes April 25, 2019, 3:00 pm, Lincoln Town Hall

1. Meeting called to order at 3:05 pm.

- 2. The TTF met with representatives from Bank of New Hampshire who went over the policies and procedures necessary to open and maintain a Wealth Management Account for the Lincoln Trustees of the Trust Funds.
- 3. First, Mr. Anderson expressed their pleasure that the Trustees have chosen BNH to manage our Capital Reserves and Trust Funds. He then went on to outline what they would like to discuss with us today:
  - Trustees will execute certain accounts that will satisfy federal and state requirements, including complying with those required by the federal Patriot Act.
  - Trustees will sign and send wiring instructions to Citizens Bank instructing them to wire cash to BNH;
  - There will be three accounts, one for Capital Reserve and one for Trust Funds, as well as a checking account;
  - Once funds have been received, BNH will come and meet with the Trustees again, during which the Trustees will learn more about the methods used to manage said accounts, as well as go over what documentation the TTF will be receiving on a monthly basis;
  - BNH will create and maintain, on a monthly basis, the state MS-9 reports;
  - During the transition period, Trustees will send to BNH any Citizens agreements and bank statements to ensure all funds that are meant to be transferred will have been transferred from Citizens to BNH;
  - Mr. Anderson reiterated that, as relates to this new service with BNH, the TTF is a "client-at-will" and can close out of any agreement at any time.
  - Trustees signed a number of forms;
  - BNH asked if we had a written investment policy. When shown to them, they
    commented that it was broader than most they had seen, but suited their needs.
    They asked for a signed copy and were informed that there would need to be a
    vote which can be taken today; (See below)
  - Ms. Linden went over what information we would be receiving monthly and had copies of various forms that will be used;
  - Next meeting date has been scheduled for Thursday, June 6, at 3:00 pm;
  - The BNH team left around 4:15 pm.

  - Bev gave Jeanne User ID and password to log into Citizens accessESCROW where TTF's accounts can be viewed.
  - Jeanne has had some problems becoming a signatory on TTF's Citizens account; she now has a copy of the letter sent by the Select Board to Citizens notifying them of Lutz Wallem's departure and Jeanne's appointment to the TTF.
