There was a major water main break at the Village of Loon. Thanks went out to Public Works Director Nate Hadaway and Water Plant Operator David Beaudin for the repair of the main.

There was a brief discussion about the water main and how much of the town depends upon it. More research will be done around this water main and others in town.

Cindy Perkins had a conversation with Mr. Atwood and followed up with a letter. The Select Board said that Ms. Perkins letter was very well written and informative.

Justin Roshak asked about the Levee bid process and if it was a closed or opened bid. Town Manager Burbank said that the bid will be an open bid and will be opened on February 23. The bid process was explained and that the lowest bid is not always the winning bid.
