# Town of Lincoln Board of Selectmen Meeting Minutes

#### II. PUBLIC HEARING

The Board of Selectmen opened the public hearing to accept and appropriate \$46,360.90 in unanticipated grant revenue from the State of New Hampshire.

This revenue represents funding provided by FEMA public assistance grants under disaster FEMA-4026-DR-NH (Tropical Storm Irene), for repairs to the East Branch Pemigewasset River water plant intake, Penstock Trail, Police, Fire and Public Works Department Overtime during the event, Loon Mountain Road Washout, and the Water Main Break adjacent to Octagon Lodge. There was no public comment. Peter Moore closed the public hearing.

Such revenue represents funding provided by FEMA public assistance grants under disaster FEMA-4026-DR-NH to offset costs incurred by the Town of Lincoln during 2011 for unanticipated emergency repairs made necessary by Tropical Storm Irene.
