Al, Cindy, Jim, Jack and Mike all declared candidacy to be on budget committee.

Review and Approval of Minutes:

MOTION: "To approve minutes from 1/26/21." Motion: Herb, Second: Jim Discussion: Jayne states that on line 35 it should say, "...pay their wages while...", line 128 should say, "...on board..." and line 134 should say, "...remains about...". Susan states there should be a space after January. Motion carries (with corrections) unanimously MOTION: "To approve minutes from 1/28/21." Motion: Herb, Second: Dennis Motion carries unanimously

Paul asks to have the tax impacts for each department. Johnna states she will figure those as we go through each budget.

Jack states that with a total tax impact of \$1.89 per thousand would mean that a \$300,000 home would be an increase on taxes of \$567. This has been a tough year financially on many. Paul states the difference from last year to this year is \$0.86 per thousand. Therefore, \$300,000 home would be an increase on taxes of \$258. Butch states that if the bond for water meters passes they will use the Bond Bank. It will be a 15-year bond and the first payment is due in February of 2022.

Carol states that the \$5000 grant was used for air purifiers and they were able to increase the on-line resources.

Motion to recommend funding in the amount of \$1,605,000.00: Dennis, Second: Susan Discussion: Jim states this shifts the burden of paying for water onto the year-round residents and there will be administrative and billing costs that aren't factored in. Mike is concerned about the rate structure and how it will be adjusted. Susan states that we will need the meters in order to apply for grants. Paul states that the fees will offset the water and sewer costs in the budget, but he is concerned about the price adjustments, how the adjustments will be made and by whom. He suggests a water commission be formed to handle the adjustments. Cindy states that the water committee will need to continue and help decide how those things are done. Paul asks if the \$1.6 million also covers administrative and billing. Butch states that by Thursday we will have a spreadsheet on the cost over the 15 years. Tamra states that the 2% interest is adjusted yearly on the principal balance not the original bond amount. She also states that we don't qualify for any water or sewer grants due to not having meters or charging for water and in the future, we will need a sewer system rehab. Jack states that charging a flat fee would give us a dedicated revenue stream to use for water and sewer rehab and that conservation and education are important also. Dennis asks to call the vote.
