 - c. Citizens Bank 1.00% for \$100,000.00 for 12 or 24 months.
 - d. Bank of NH .40%

Beverly Hall stated that The Roland Dubois account has approximate balance of \$163,000.00 of which we would use \$100,000.00 for the 2nd CD

Dr. Gardner will send an email to the bank that was voted on by the TTF, to let them know the decision of the board, and discuss the process of moving forward.

Motion: To agree on the highest percentage rate of Primary Bank for an 18 month CD with 2.02 % for \$100,000
